MEMORANDUM OF UNDERSTANDING

Between

KN University, Ahmedabad And

Health1 Super Speciality Hospital, Shilaj (Unit of Health1 Neuro1 Super Speciality Hospitals Pvt. Ltd.)

This Memorandum of Understanding (MoU) is entered into on this 10^{th} April 2024, by and between:

KN University, Ahmedabad, a premier institution of higher education, having its registered office Near KNPIS Circle, Gota, Ahmedabad, Gujarat-382481, hereinafter referred to as "KN University,"

AND

Health1 super speciality hospital, Shilaj a leading multi-specialty healthcare provider (Unit of Health1 Neuro1 Super Speciality Hospitals Pvt. Ltd.), having its registered office at Shilaj Circle, Sardar Patel Ring Rd, near Venetian Villa, Thaltej, Ahmedabad, Gujarat 380059 hereinafter referred to as "Health1 super speciality hospital Shilaj "Collectively referred to as the "Parties" and individually as a "Party."

1. Objective

The objective of this MoU is to establish a formal partnership between KN University andHealth1 super Speciality Hospital,Shilaj to facilitate comprehensive health services, including preventive health check-ups and emergency medical care, for the faculty members, administrative staff, and students of KN University and its constituent Schools.

2.Scope of Collaboration

Health1 super speciality hospital,Shilaj shall extend the following services under this MoU:

2.1 Preventive Health Services

- Annual health screening packages tailored for faculty, staff, and students at preferential rates.
- Organization of periodic on-campus health camps, including general check-ups, dental, ophthalmic, and lifestyle screenings.
- Vaccination drives and wellness consultations as per public health advisories.

2.2 Emergency Medical Services

- Priority access to emergency care for KN University members.
- Dedicated ambulance support for on-campus emergencies.
- 24x7 emergency helpline for immediate medical assistance.

2.3 Outpatient and Inpatient Care

- Preferential appointment scheduling for consultations and diagnostics.
- Discounted rates for select outpatient and inpatient services.



- Cashless treatment options subject to prior approval and institutional policy.
 Health Education and Awareness
 - Joint organization of seminars, workshops, and awareness campaigns on preventive healthcare, mental wellbeing, nutrition, and lifestyle management.
 - Participation in university wellness initiatives and student support programs.

3. Responsibilities of KN University

KN University shall:

- Facilitate coordination between its departments and Samata Multi-speciality Hospital for smooth implementation of services.
- Provide timely communication and logistical support for on-campus medical activities.
- Share verified lists of eligible beneficiaries for service access.
- Promote the partnership through internal circulars, student handbooks, and digital platforms.

4. Financial Terms

- Services shall be rendered at mutually agreed concessional rates, detailed in Annexure A.
- Payment modalities shall be governed by institutional policy, with options for individual or institutional coverage.
- Any additional services beyond the agreed scope shall be subject to separate billing and prior consent.

5. Duration and Validity

This MoU shall be valid for a period of **three (3) years** from the date of execution and may be renewed upon mutual agreement.

6. Confidentiality

Both Parties shall maintain strict confidentiality of personal health data and institutional information, in accordance with applicable laws including the Information Technology Act, 2000 and relevant medical ethics.

7. Termination Clause

Either Party may terminate this MoU by providing sixty (60) days' written notice, subject to the settlement of any outstanding obligations.

8.Dispute Resolution

Any disputes arising out of or in connection with this MoU shall be resolved amicably through mutual consultation. Failing which, the matter shall be referred to arbitration



under the Arbitration and Conciliation Act, 1996. The venue of arbitration shall be Ahmedabad and the language shall be English/Gujarati.

9.General Provisions

- This MoU does not constitute a legal partnership or employment relationship between the Parties.
- Amendments to this MoU shall be made in writing and duly signed by authorized representatives of both Parties.
- Any annexures, schedules, or supplementary documents shall form an integral part of this MoU.
